

- (4) Court Room 6 Civil Court Three (3)
- (5) Court Room 7 Civil Court Four (4), Human Rights, Election Petitions, Leadership Tribunals, etc.
- (6) Court Room 8 Civil Court Two (2)
- (7) Court Room 9 Civil Court One (1)
- (8) Court Room 10 Commercial

These arrangements are subject to the need to use either Court Room 1, 2, or 3 when the nature of a case may require the need to use these Court Rooms. When the need to swap these court rooms arise that Judges consult one another personally has been the current practice.
