

Foreword by the Chief Justice



The focus this legal year 2022 is once again on the need to increase case disposition to reduce backlogs in both the Criminal and Civil lists. We achieved case dispositions in the Supreme Court. We are still lagging in speeder case deposition in the National Court. Our efforts and focus will be on the disposition of backlog of cases in the National Court and disposal of reserved decisions of the National Court. This is a daunting task but can be delivered with renewed vigour, persistence, more use of mediation and a change in work ethics and attitude by the Judges.

The idea of having Supreme Court sittings every month from 2020 to now worked well but needs improvement. With a lot more focused effort we will continue to have the Supreme Court sit every month for a week.

From 2019 to now, we trialed the Integrated Electronic Case Management System. We have connectivity through Satellite network to most of PNG. That was made possible by the launch of the Kacific Satellite. That was made possible by the launch of the Kacific Satellite. We purchased the required satellite dishes and rolled them out and installed them in all the provinces throughout the country. That exercise is complete. We will now conduct more trainings for lawyers and stakeholders. A lot more training is needed to have the system fully functional. We await the completion of the Waigani Court Complex hopefully in 2022. We are optimistic that going electronic and digital and a lot more use of mediation in appropriate cases will help us increase our case disposition rate, minimize and reduce our backlogs, minimize lengthy reserved decisions, promote transparency and honesty and promote access

to Justice issues to all at the same time. All this contributes to improving our case management

and good governance and will enhance the maintenance of the rule of Law.

The Calendar is a guide only and adherence to it depends on budgetary and other unforeseen

factors beyond our control as to whether a circuit will be mounted or not. Lawyers especially

from the Office of the Public Prosecutor and the Public Solicitor are a big part of the success

of a Court Calendar. Their availability is dependent entirely on the budget support given to

them by the State.

The calendar has information on judicial administration, Judges postings, Court Registries and

Sub-registries in the provinces.
